- The staff must set an example of excellence in Scouting which includes the proper wearing of the uniform.

If applicant is accepted for employment the following will be required:

- All staff will be required to provide proof of identity and right to employment before beginning work.
- All staff must complete all required training and sign a Code of Conduct. Failure to adhere to Code of Conduct may result in termination of employment.
- All staff must submit PA Act 139 Clearances.
- All staff must have current BSA Youth Protection Training.
- All staff must submit a BSA Medical Form to the Camp Health Officer upon arrival at camp.
- All staff must be willing to live by the Scout Oath and Law.
